Secretary's Report

E-board, Saturday December 19, 2015-Chris Myers KB1NEK

There was no program meeting in December and the program meeting was replaced by the holiday pot luck and auction (see below).

Minutes of FCARC e-board meeting Sat. 19 December 2015, at Business conference room, East Bldg., GCC

1. Bruce moved that club donate \$100 to the Humane Society, an animal rescue

organization connected to the Franklin County Sheriff's office, in memory of Tom Foxwell, who died earlier in the week. Tom had been a president of the club and a District Emergency Coordinator in ARES, as well as a member of the Franklin County CERT from the time it was formed over ten years ago.

2. A discussion was started on the best strategy for using a new Yaesu DR-1X repeater, which the membership voted to acquire at the meeting held during the holiday party. Everyone agrees it would be useful as a spare, but not entirely in agreement on how best to set it up to be ready when needed.

The Yaesu program requires that a club getting one of these repeaters must keep it actually on the air for a year. The safest strategy would be to place it in the water works shed on Rocky Mount in Greenfield, and operate it on 2m, with minimum power setting. If it works as regular analog repeater on the same frequency pair as the Leyden repeater, without causing noticeable interference, that would be the best plan. If it turns out to cause interference with the Leyden repeater, then we could set it to run digital only.

Keith plans to fill an application to get a new frequency pair from the New England Spectrum Management Council (NESMC). He is not sure what frequency pair to ask for. Chris offered to research the frequencies in use. If we decide to use the new DR-1X on a new frequency pair, on the 2m band, we would have to get the duplexer already stored at Rocky Mount retuned to the new frequencies. No one in the club knows how to do this kind of tuning, so we would have to contract it out. If we re-tune the duplexer, then it would not be of any use if we need to use the new DR-1X on the air from Greenfield, to replace the Leyden repeater if it breaks down.

We all agreed to go ahead and have Keith put in an order for one new DR-1X.

Bruce asked if there is any way we could have e-board meetings on some other time than Monday evenings. We have been meeting on Mondays just before the regular membership meeting as a way to save travel time. No one wanted to change that. Bruce said he has an unavoidable conflict every Monday evening, so will have to resign from the eboard. We agreed not to fill the position until the next meeting.

After the e-board meeting adjourned, Bruce asked Chris to discuss the status of emergency communications. Jeanne, who was correcting final exams, joined the discussion. The three of us agree we could try to pull together regular discussions among local hams interested in emergency communications if we met after club breakfasts. Jeanne asked to have mentoring assistance to help get her on the air. Chris offered to get her a J-pole antenna and install it in her apartment. Chris also mentioned that in recent months he has been trying to help Carolyn Ness, KB1WTQ get on the air.

Jeanne thinks that this activity might be of interest to some students at GCC. She will ask around.

We agreed to spread the word and try to convene a meeting after the club breakfast, February 13
