Some thoughts on how to teach a licensing class - AI, N1AW

Many of you have probably heard of Dan Romanchik, KB6NU. He is the author of the No-Nonsense Study Guides for amateur license exams which I have recommended for reviewing before taking license exams. He also maintains a blog on ham radio topics and sends out monthly posts for possible use in club newsletters to hundreds of ham radio clubs - we have occasionally used these for the Communicator.

He happened to call CQ on 80 meters last night just after our Snail Net and very close to our frequency. I recognized his callsign and went back to him, and we had a short QSO. I mentioned being familiar with the study guides and he asked how we used them. I told him we did not do one-day classes, and had a preference for classes that didn't just prepare for the exams. But I told him that I recommended his study guides for review before taking license exams. You can't say much in a 20 minute CW QSO and 80 meters was noisy last night, so today I sent him an e-mail to say a bit more. I got a response from him that I thought would be interesting for us to think about as we plan for another class in February. I thought his reply might be of interest to some of us.

Here is part of what I wrote to Dan about our club's and my own experiences:

Since you asked about how my group does classes, I'll amplify a little bit what I hinted at on CW. I was a college teacher for many years, and for the Technician license classes our little club has put on in recent years I and my colleagues felt that just teaching to the test did not appeal to us - we mostly used the ARRL book and taught our classes once a week for six weeks. We did distribute on CD your No-Nonsense Study Guide and recommended using it during review for the exams. We did this twice, in 2012 and 2013, and found it somewhat unsatisfactory in several ways. First we were not happy with the number of participants we got - about a dozen in 2012 and fewer in 2014 - and we had a lot of dropouts, with only about 8 and 4 participants from each class continuing through to the exam sessions. Most passed,

the main exception being an 11 year old boy who I think was just not intellectually ready for the elementary algebra needed for Ohm's Law and wavelength-frequency relationships (I actually discussed this with one of his 6th grade teachers). But we were pretty discouraged, which is part of the reason we have gone so long without teaching another class.

Our Franklin County ARC is in one of the most rural areas of Massachusetts (I live in a town with population about 700). There are perhaps 120 licensed hams in our county and if we get 15 at a monthly meeting or 30 to participate in Field Day we think we are doing well. We do regular VE sessions four times a year and we typically get 2, 3, or 4 applicants at each session There is a much larger club, the Hampden County Radio Association, based in the large city of Springfield MA, which runs week-long, four session classes - two weekday evenings and a Saturday morning study sessions, and then the VE session on Saturday afternoon. They generally do one of these each year, with the main emphasis being preparation for the Technician license using projected multiple-choice materials. They also offer small group review (not study) sessions for General and Extra class exams. Participants are told of the No-Nonsense materials and they are recommended for review, but I'm not sure how much they are actually used.

I'm also a member of the HCRA and I have volunteered to help with these sessions on three occasions so far. For me it's a long drive for an evening session and I often have Saturday conflicts, so I schedule myself as a floater available to help when I can make it. I was initially motivated by a desire to see how the quick exam-oriented classes worked, and I have become convinced they do work. I've told members of my own group that the emphasis on getting people licensed will get people involved in the hobby, and that this will in turn motivate them to gain the understanding and the context that could come from a more conventional class.

So, in Franklin County we are now planning a Technician exam class for late winter. It will not be as compactly scheduled as the Hampden County sessions because we are doing it on the campus of our local Community College. We hope to get participation by students. Two evenings a week for two weeks plus a Saturday morning exam session seem to be the best way to be compatible with student schedules. I expect we will use a combination of minilectures and multiple choice materials for the evening sessions, but I am planning to also make the Non-Nonsense materials available and recommend them for final review.

I'd welcome any comments on this.
