# Secretary's Report

E-Board and Program Meeting, Monday January 13, 2020 at GCC, Chris Myers KB1NEK

E board meeting Notes:

(Note, this contains some corrections to the original draft)

1. Aaron passed out an agenda that included a list of the equipment he had retrieved from the Greenfield Fire Station. This equipment had been loaned by the club to the Greenfield EOC to be used for Vermont Yankee drills and actual emergency use where amateur radio communication was called for.

After this list is published in the Communicator, some of these items will be offered up for auction. The auction will take place on Aaron's website [more info below]. Whatever is left will go to various hamfests for sale.

- 2. A motion was made and passed to reimburse Keith for the \$61.74 he spent to ship the recently purchased club TS-590 back to California for repairs. The radio has been returned and tested by Keith and Chris, and seems to perform as specified.
- 3. There was some discussion about the possibility of purchasing coaxial cable jumpers to use at the MACC site at GCC. In view of the results of recent testing at that site, it was decided to table the discussion of any additional club purchases.
- 4. Keith requested Al to give Chris and club clerk, Erika, information needed to log into and update the FCARC website, as well as the information needed to maintain the web address and hosting service.
- 5. Aaron suggested creating a separate bank account for ARES use. Howard explained that he now has to keep track of three separate pools of money in one single bank account. Besides the club's own money, the account includes \$226 from the VE team, and \$1198 from the High School club, which no longer shows much sign of life. Since license tests are now being done by the Laurel group, it should be possible to dispose of the \$226 from the VE team. Because Al was not present, we decided not to make a decision on this.

General Membership meeting started at 7:15

After the adjournment of the e-board meeting, Mark Foster, from the Shrewsbury EOC team made a presentation on personal emergency go kits, often called Bug out Bags (B.O.B's).



#### **Progress with an Old Transceiver**

#### Al N1AW and Brad W1BCC

The club auctioned off an old Kenwood TS-830S transceiver at our December Holiday party. Al, as auctioneer, was careful to warn that this is a hybrid, with a vacuum tube final power amplifier using high, potentially lethal voltages. To prevent damage to the tubes careful adjustments are required, a procedure which users of modern transistorized transmitters probably have never had to perform.

Brad, unfazed by the warnings, bid for and won the TS-830. Recently he wrote, "This weekend I finally started playing with the TS-830S. Reminds me of tuning my DX-60 way back in the day. Interesting to note that I've now gone from one 6146 to two.

"Impressed by the receiver. I like the variable band pass tuning. Reasonably stable after 30 mins or so. Stumbled a bit until I learned that CW won't work with the VOX off (duh). As for SSB, I wired up an old 500 ohm CB mic. Looks like it is working. Now trying to find a test partner on 75m. Will let you know."

#### WXM68 on Frizzell Hill

Most hams are aware that the National Weather Service has 24 hour weather broadcasts on VHF frequencies that can be received by most 2 meter radios. The nearest such transmitter used to be on Ames Hill near Brattleboro, supported by the Vernon nuclear power plant. After Vernon closed down, the Ames

Hill station also shut down and our nearest weather broadcasts came from a transmitter on Pack Monadnock, not easily received in many parts of Franklin County. But recently the station previously located on Ames hill was reactivated at the WPVQ transmitter site on Frizzell Hill in Leyden - the same place as our KB1BSS 146.985 MHz repeater. The Leyden NWS station is WXM68 and it broadcasts on 162.425 MHz.

It turns out the technician who installed and may get called upon to service the WXM68 weather station is a ham, Brett, KA4ZEO. I happened to meet him on the air when he was putting the weather station on the air for the first time. He is based in Albany. There is a dedicated phone line with which his office can check the status of the weather transmitter. But a week or two ago the phone line was out of service, and Brett called me to ask if the weather station sounded OK here. I was not surprised, I live about a mile down the road from our repeater site and I have problems with my own Verizon landline phone service occasionally.

On that occasion all was OK with the WXM68 station. But subsequently Brett wrote me to say that if a problem with the station is noticed it can be reported by e-mail to <a href="mailto:alb.stormreport@noaa.gov">alb.stormreport@noaa.gov</a> or a call to 518-435-9571.
